Rosemary Mulryan served as the President of the Gerber/Hart Board of Directors from 1989 – 1992. Mulryan is an attorney focusing on adoption law and LGBT families. In 1988, she founded, with Mary York, one of Chicago's first woman-owned law firms.

Custodial History:

The collection donated in 1993 and received by Mike Sarna. The collection was accessioned on September 11, 1996 by Diane Asseln. The collection is in good condition and is in its original arrangement.

Scope and Content:

The collection contains materials from Mulryan's tenure as President. It includes correspondence, Board of Directors meeting minutes, and Gerber/Hart internal materials on financing, fundraising, personnel, contributors, and membership.
